
Statement pursuant to NRS 233B.061.3(1) to implement emergency regulations


As a result of the COVID-19 pandemic emergency declaration, the Department of Motor Vehicles (DMV) is submitting this emergency regulation to allow the DMV the ability to utilize its alternate services platforms to perform driver license and identification card renewals. Currently, all identification card holders as well as driver license holders under 65 years of age, are required to appear in a DMV office for these renewal transactions. This emergency regulation will allow eligible applicants to use the DMV's alternate services, including, but not limited to online services, mail or KIOSKs for renewing credentials during a time when DMV offices are unable to assist customers due to COVID-19 restrictions.

EMERGENCY REGULATION OF THE
NEVADA DEPARTMENT OF MOTOR VEHICLES

July 20, 2020

Matter in *italics* is new.

Filing of an Emergency Administrative Regulation

AUTHORITY: NRS 481.051, 483.220, 483.380

Section 1. NAC 483.043 is hereby amended to read as follows:

1. Except as otherwise provided in subsection 3, [NRS 483.283](#), [483.291](#) or [483.861](#) or [NAC 483.832](#), and except for a limited-term driver's license or limited-term identification card, every driver's license, motorcycle driver's license or identification card expires on the eighth anniversary of the birthday of the licensee or holder of the identification card measured, in the case of an original issuance, a renewal of a driver's license, motorcycle driver's license or identification card or a renewal of an expired driver's license, motorcycle driver's license or identification card, from the birthday of the licensee or holder nearest the date of issuance or renewal.
2. Except as otherwise provided in [NAC 483.084](#) and [483.4575](#), a licensee or holder of the identification card whose driver's license, motorcycle driver's license or identification card expires on the eighth anniversary of the birthday of the licensee or holder of the identification card must, *at every other renewal*, renew his or her driver's license, motorcycle driver's license or identification card in person at an office of the Department.
3. A driver's license or motorcycle driver's license issued to a licensee who is 65 years of age or older on the date of issuance or renewal expires on the fourth anniversary of the birthday of the licensee measured, in the case of an original issuance, a renewal of a driver's license or motorcycle driver's license or a renewal of an expired driver's license or motorcycle driver's license, from the birthday of the licensee nearest the date of issuance or renewal.
4. *The Director of the Department may grant an automatic extension for up to 1 year on a driver's license issued pursuant to subsection 3 necessary to lessen the impact on driver's license holders caused by the limited re-opening of Department offices statewide due to the COVID-19 pandemic.*
45. *The extension granted in subsection 4 will be a manual extension where a new card will not be produced.*
6. For the purposes of this chapter, any applicant, licensee or holder of an identification card whose date of birth was on February 29 in a leap year shall be deemed to have a birthdate of February 28.

Section 2. NAC 483.832 is hereby amended to read as follows:

1. Except as otherwise provided in subsection 3 or NRS 483.929, and except for a limited-term driver's license, every commercial driver's license expires on the eighth anniversary of the date of issuance of the commercial driver's license, in the case of an original issuance, a renewal of a commercial driver's license or a renewal of an expired commercial driver's license.
2. A licensee must, *at every other renewal*, renew his or her commercial driver's license in person at an office of the Department.

3. A commercial driver's license issued to a licensee who is 65 years of age or older on the date of issuance or renewal expires on the fourth anniversary of the birthday of the licensee measured, in the case of an original issuance, a renewal of a commercial driver's license or a renewal of an expired commercial driver's license, from the birthday of the licensee or holder nearest the date of issuance or renewal.

4. The Director of the Department may grant an automatic extension for up to 1 year on a driver's license issued pursuant to subsection 3 necessary to lessen the impact on driver's license holders caused by the limited re-opening of Department offices statewide due to the COVID-19 pandemic.

5. The extension granted in subsection 4 will be a manual extension where a new card will not be produced.

INFORMATIONAL STATEMENT OF ADOPTED EMERGENCY REGULATIONS
AS REQUIRED BY ADMINISTRATIVE PROCEDURES ACT, NRS 233B.066

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) 483.

(a) *A clear and concise explanation of the need for the adopted regulation*

Currently, by regulation, all Department of Motor Vehicles credentials (driver license, commercial driver license and identification card) issued for an 8-year period are required to be renewed in-person, at an office of the Department.

In response to the COVID-19 pandemic, the Department is requesting this emergency regulation to obtain the authority to only require in person renewals at every other 8-year renewal.
